In pursuance to the powers conferred under SRO-43 of 02/1994, sanction is hereby accorded to the temporary appointment of Sh. Mukesh Singh against the death of his father Late Pritam Singh (Ex- AMM) as Turn Cock in Jal Shakti (PHE) Department Jammu in the revised pay Level SL-1 (14800-47100) in relaxation of technical qualification bar and Higher qualification bar for appointment against Class-IV post.

Consequent upon his appointment he further posted in Jal Shakti (PHE) Division Kathua against a vacant post of Turn Cock after receipt of satisfactory character and antecedents verification report from Special Director General, CID, J&K.

The appointee shall report to the Executive Engineer, Jal Shakti (PHE) Division Kathua within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health certificate from the concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner Revenue.
6. If the candidate (s) has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District he shall relinquish the proprietorship of unit/enterprise and also stocks, if any, in such self employment unit/enterprise before the joining the Government Services. He shall be required to liquidate the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stocks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
7. Category Certificate, if any.
8. All other relevant documents as are required under SRO-43 of 02/1994.

The appointment of the appointee shall further be subject to the following conditions:

- a. That he shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate, 1st Class to the effect that if on verification, genuineness of the qualification/date of birth certificates and any other relevant certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Turn Cock shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above received in his favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- d. If the appointee fails to join within a period of twenty one (21) days from the date of issuance of order he shall forego right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- e. This order is issued in pursuance to Rule-18 (C) of S.O. 429 i.e. Jammu & Kashmir Rehabilitation Assistance Scheme 2022 issued vide notification dated: 06-09-2022.

The appointee shall be on probation for a period of two (02) years in the first instance as per Rule-20 of J&K Civil Services (CCA) Rules, 1956 and his further continuation shall be made subject to the recommendations/report of the satisfactory performance as Turn Cock from the concerned Executive Engineer/Superintending Engineer.

This order is, however, subject to outcome of writ petition(s) if any, pending in any competent Court of Law.
