
In pursuance to the powers conferred under SRO-43 of 02/1994, sanction is hereby accorded to the temporary appointment of Sh. Naresh Kumar against the death of his father Late Chaman Lal (Ex- Helper) as Khalasi in Jal Shakti (PHE) Department Jammu in the revised pay Level SL-1 (14800-47100) in relaxation of technical qualification bar.

Consequent upon his appointment he further posted in Jal Shakti (PHE) Mechanical Division Rajouri against a vacant post of Khalasi after receipt of satisfactory character and antecedents verification report from Special Director General, CID, J&K.

The appointee shall report to the Executive Engineer, Jal Shakti (PHE) Mechanical Division Rajouri within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates;

- 1. Academic Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Domicile Certificate.
- 4. Health certificate from the concerned Chief Medical Officer of the District.
- 5. Dependent Certificate issued by the Assistant Commissioner Revenue.
- 6. If the candidate (s) has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District he/she shall relinquish the proprietorship of unit/enterprise and also stacks, if any, in such self employment unit/enterprise before the joining the Government Services. He/She shall be required to liquidate the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitory its recovery.
- 7. Category Certificate, if any.
- 8. All other relevant documents as are required under SRO-43 of 02/1994.

The appointment of the appointee shall further be subject to the following conditions:

- a. That he shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate, 1st Class to the effect that if on verification, genuineness of the qualification/date of birth certificates and any other relevant certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Khalasi shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above received in his favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- d. If the appointee fails to join within a period of twenty one (21) days from the date of issuance of order he shall forego right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- e. This order is issued in pursuance to Rule-18 (C) of S.O. 429 i.e. Jammu & Kashmir Rehabilitation Assistance Scheme 2022 issued vide notification dated: 06-09-2022.

The appointee shall be on probation for a period of two (02) years in the first instance as per Rule-20 of J&K Civil Services (CCA) Rules, 1956 and his further continuation shall be made subject to the recommendations/report of the satisfactory performance as Khalasi from the concerned Executive Engineer/Superintending Engineer.

This order is, however, subject to outcome of writ petition(s) if any, pending in any competent Court of Law.
