Subject:- Seniority list of confirmed Superintending Engineers, Jal Shakti Department as it stood on 01.01.2021.

Circular No. 01-JK (JSD) of 2021 Dated: - // .02.2021

Whereas, Government Order No.355-PW (Hyd) of 2017 dated 25.08.2017, year wise final seniority list of Superintending Engineers (Civil) of PHE, I& FC Department (now Jal Shakti Department) as it stood on 01.01.2013 to 01.01.2017 was issued; and

Whereas, on the recommendations of the DPC/J&K Public Service Commission vide Government Order No. 236-JK(JSD) of 2020 dated 31.12.2020, 26 (twenty six) Executive Engineers have been promoted/regularized as Superintending Engineers from various retrospectively dates; and

Whereas, J&K Public Service Commission had conveyed that the DPC/PSC cleared some Assistant Executive Engineers belonging to reserved categories for their regularization/ promotion as Executive Engineers from their respective dates. However, formal orders could not been issued in view of the General Administration Department advisory issued vide their O.M No. GAD / MTG/ RB- IV/04/2016 dated 21.06.2016, as the entered reservation in promotions is presently sub-judice in the Apex Court. Their seniority shall be fixed at suitable position later after their regularization/ promotion order shall be issued; and

Whereas, the seniority of such officers whose regularization as Superintending Engineers has been deferred by the DPC/ PSC for want of vigilance clearance, pending departmental enquiry or any other reasons, their seniority shall also be fixed at appropriate places, after their regularization as Superintending Engineers are cleared by the DPC/ PSC; and

Whereas, a number of changes have taken place due to retirement/ death of the officers. These changes have necessitated up-dation of seniority list of confirmed Superintending Engineers (Civil) of Jal Shakti Department; and

Whereas, further, it is imperative to frame the tentative Seniority list of confirmed Superintending Engineers as it stood on 01.01.2021, in order to make regularization/promotion of eligible officers as Chief Engineers.

Now, therefore, tentative Seniority list of the confirmed Superintending Engineers (Civil) of Jal Shakti Department as it stood on 01.01.2021, has been framed as per Annexure to this Circular.

Members of the services are, accordingly, directed to file their objections, if any, in the Administrative Department (HRM Branch) Civil Secretariat, Jammu or through their respective Heads of Departments within a period of 15 days from the date of issuance of this Circular with documentary proof in support of their claim after which no objection (s) shall be entertained and Final Seniority list shall be
